- Tim has been a solicitor since 1981.
- Tim practiced as a commercial litigator for 23 years and since 1989 has developed extensive expertise in the area of mediation and is highly respected within the legal profession for his commercially focused, proactive, balanced and well-researched conflict resolution approach.
- In 2001, he established McFarlane Legal, Dispute Resolution, which exclusively provides specialist mediation and conflict resolution services. He has since expanded the practice to employ two other mediators, both of whom have long been engaged in this area and bring extensive legal expertise and experience in dispute resolution to the firm.
- Tim was accredited as a Specialist in Alternative Dispute Resolution (Mediation) in the first group approved by the Law Institute of Victoria in 1993.
- He is a member of a number of mediation committees and panels in Victoria and overseas and previously held roles as Chairman of the Mediation Advisory Committee for 12 years, founding Director of the National Mediators Standards Board (now AMDRAS*) and a member of the Law Council of Australia ADR Committee. (*Australian Mediator and Dispute Resolution Accreditation Standards).
- Tim has conducted in excess of 14,200 mediations face to face and online, involving parties both within Australia and overseas, in all areas of conflict and jurisdictions including:
